Please note that Ministry of Construction, Transport and Infrastructure (MCTI) - Directorate for Inland Waterways is defined as an Investor by the Government of the Republic of Serbia, and by that authority, MCTI - Directorate for Inland Waterways performed all activities in line with the Law on Planning and Construction of the Republic of Serbia, including obtaining of the Conditions, Approvals and Permits for the execution of works, i.e. construction permits. No obligation related to obtaining the Construction Permits is posed to the Contractor. The wording " <i>tenderer must take into account</i> " means that the Contractor, prior to works commencement, must make sure that conditions and permits are obtained and to make sure to have all documents necessary in order to be able to start the construction works. This also refers to documents which are the responsibility of the Contractor in the phase of the execution of works and that might impact Contractors work-plan.

Please clarify the following: Cash Flow Statement should be submitted either for years 2013, 2014 and 2015 (as it was requested for Balance sheet), or for 2015 year only.	
3	 According to General Instructions to Tenderers, please answer us these questions: 1. 12.2.1., B) Professional Capacity of Candidate: Please note that before the contract commencement date, the tenderer must demonstrate that he possesses the proper licenses according to the Serbian Law for the Planning and Construction. 1. Question: Are those licenses И160Г3, П160Г3? 	 Proper licenses according to the Serbian Law on Planning and Construction, must be obtained by the Contractor, if not already in the possession of the Contractor, before the contract commencement date. This refers to the following articles of the Law on Planning and Construction (Official Gazette of the Republic of Serbia no. 72/2009, 81/2009 - corr., 64/2010 - decision US, 24/2011, 121/2012, 42/2013 - decision US, 50/2013 - decision US, 98/2013 - decision US, 132/2014 and 145/2014): Article 133, subpart 2, point 17) defines river training structures as objects for which a Construction permit is obligatory; Article 150, subpart 2 defines conditions for Contractors for execution of construction works for objects which are falling under the Article 130, subpart 2, including licenses; Articles 151 and 152 defines obligations of the Contractor, including licenses. No license related to design is required, only licenses related to execution of specific construction works.

Does it mean that equipment will retain to Contractor or Beneficiary or Supervision? 	 a) According to the Tender Dossier Volume 3, Section 1.3.2. Vessel with hydrographic survey equipment and ADCP equipment, the length of the vessel is defined as "up to 6 m, maximum weight of 900 kg". In line with that, the length of the vessel should be less or equal to 6 m. b) No equipment will be retained by the Beneficiaries, nor by the Supervising Engineer.
6	Regarding tender documents for" River training and dredging works on critical sectors on the Danube river" in Volume 1, section 4, the Contracting Authority give to the Contractor the opportunity to rent the equipment for implementation of the contract according to Form 4.6.2.1 and Note 1 from the bottom of the page, such as survey vessel, but in Volume 3, Contracting Authority require buying this survey vessel. Please clarify this issue. Please send all information necessary regarding the sizes of vessel.	In Volume 3, Section 1.3 – Engineer's Requirements, it is written: "The Contractor will make available the following facilities and equipment for the use of the Engineer, for the duration of the Works Contract: Vessel with hydrographic survey equipment and ADCP equipment" The vessel must be available for the use of the Engineer for the duration of the Works Contract. No equipment will be retained by the Beneficiary nor by the Supervising Engineer at the end of the Contract. Additionally, please note that in the ITTs- Article 12 - Information / Documents to Be Supplied by the Tenderer, Sub-article 12.1.9 it is stipulated: "a list of plant for execution of the contract. The descriptions must demonstrate the tenderer's ability to complete the works and should include
