## CONTRACT SPECIFICATION

**6. Nature of contract**

Fee-based

**7. Contract description**

The purpose of this contract is to provide technical assistance and supervision services for fulfilling duties of the “Engineer” as specified in the FIDIC conditions of contract. Supervision is to be provided for the construction of the raw water supply system and reconstruction and upgrade of sewage system (according to FIDIC Red Book) as well as construction of waste water treatment plant (according to FIDIC Yellow Book) for the City of Raška. Services to be provided are not limited to supervision of construction, but include project management support and preparation of Financial and Operational Performance Improvement Programme (FOPIP) to train operating staff and other stakeholders and thereby ensure the effective functioning of the Public Utility Company „Raška,, in charge for management of wastewater treatment. The contract should help implementation of the project by putting in place reliable and sustainable waste water management system and ensuring its effective functioning.

**8. Number and titles of lots**

No, one lot only

**9. Maximum budget**

EUR 661.900,00

**10. Scope for additional services**

The Contracting Authority may, at its own discretion, extend the project in duration and/or scope subject to the availability of funding up to a maximum not exceeding the length and value of the initial contract. Any extension of the contract would be subject to satisfactory performance by the Contractor.

## CONDITIONS OF PARTICIPATION

### 11. Eligibility

Participation is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see item 29 below). All goods supplied under this contract must originate in one or more of these countries. Participation is also open to international organisations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

### 12. Candidature

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (ie, the leader and all other members) are jointly and severally liable to the Contracting Authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

### 13. Number of applications

No more than one application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than one application, all applications in which that person has participated will be excluded.

### 14. Shortlist alliances prohibited

Any tenders received from tenderers comprising firms other than those mentioned in the short-listed application forms will be excluded from this restricted tender procedure unless prior approval from the Contracting Authority has been obtained (see Practical Guide – PRAG-2.4.3.). Short-listed candidates may not form alliances or subcontract to each other for the contract in question.

### 15. Grounds for exclusion

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the PRAG

### 16. Sub-contracting

Subcontracting is allowed up to 15% of the contract value

### 17. Number of candidates to be short-listed

On the basis of the applications received, between 4 and 8 candidates will be invited to submit detailed tenders for this contract. If the number of eligible candidates meeting the selection criteria is less than the minimum of 4, the Contracting Authority may invite the candidates who satisfy the criteria to submit a tender.

**SELECTION AND AWARD CRITERIA**

**21. Selection criteria**

Same criteria for legal and natural person

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- 1) **Economic and financial capacity of candidate** (based on item 3 of the application form).  
In case of candidate being a public body, equivalent information should be provided.
  - a) The average annual turnover of the candidate in the last three years (2012, 2013 and 2014) must be at least EUR 660.000.
  - b) Average current ratio (current assets/ current liabilities) over the last three years (2012, 2013 and 2014) must be >1.
- 2) **Professional capacity of candidate** (based on items 4 and 5 of the application form)
  - a) At least ten (10) permanent staff currently works for the candidate in fields related to this contract.
- 3) **Technical capacity of candidate** (based on items 5 and 6 of the application form)
  - a) The candidate has provided services under at least one contract (with a proportion of the contract carried out by the legal entity being at least EUR 395.000) which includes supervision of construction of waste water treatment plant for secondary treatment level with capacity of at least 15.000 P.E. including sludge line according to the FIDIC Yellow book Conditions of Contract which were implemented at any moment during the following period: in the course of the past 4 years (starting from 1st of January 2011 up to the deadline for receipt of application). AND
  - b) The candidate has provided services under at least one contract (with a proportion of the contract carried out by the legal entity being at least EUR 265.000) which includes supervision of construction for sewage network with a minimum length of 10 km according to the FIDIC Red book Conditions of Contract which were implemented at any moment during the following period: in the course of the past 4 years (starting from 1st of January 2011 up to the deadline for receipt of application).

For the both criteria under 21.3) this means that the project the candidate refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Candidates are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, proof of final payment). In case of projects still on-going only the portion satisfactorily completed during the reference period will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value. If a candidate has implemented the project in a consortium, the percentage that the candidate has successfully completed must be clear from the documentary evidence, together with a description of the nature of the services provided if the selection criteria relating to the pertinence of the experience have been used.

If the candidate/tenderer proves that the selection criteria listed under 21.3.a) and 21.3.b) are fulfilled through the execution of one single contract that covers both required fields and sum of required values, the reference shall be accepted as valid.

Previous experience which caused breach of contract and termination by a Contracting Authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be reexamined to identify the eight best candidates. The only factors which will be taken into consideration during this re-examination are:

- 1) The total number of the reference projects found eligible under 21.3. a) and in case of equality on this criterion, then:
- 2) The value of the eligible part (with a proportion of the contract carried out by the legal entity) of this projects found eligible under 21.3 a).
