No.	Question	Answer
1.	The purpose of this tender requirements is to demonstrate that tenderer has technical competence in the field relevant to the contract. With this in mind, the requirements are usually set for tenderer to prove that he has successfully delivered the system and/or equipment of similar complexity. Introducing project budget as a parameter is not comparable due to existence of other parameters not relevant to this tender (such as different project financing, equipment location, price changes etc). Can you please confirm that the delivery of similar system of at least same complexity as the one required by this tender (i.e. weather information system with at least the same number of weather stations, software and training) during the reference period is acceptable to demonstrate technical capacity of the tenderer?	As stipulated clearly in the Contract Notice, Selection criteria 16.3) Technical capacity of tenderer: "The tenderer has delivered supplies under at least one contract with a budget of at least that of his financial offer for this tender in the field related to this contract (supply of equipment, software and training for Road Weather Information System), which was implemented during the reference period."

Upgrade of the existing weather stations It is required by the tender to perform the upgrade of the already delivered 9 weather stations by providing 9 RWIS conversion kits (section 3.3.9) and that more technical detail is available in the Appendix 1 of the technical	Technical documentation for all existing weather stations, details of hardware interface and protocol description for sensors will be made available to the successful tenderer after signing of the contract.
