

Novi Pazar Emergency Service general information

- **Objective:** To improve conditions for the provision of necessary medical aid delivered to 55,000 patients of Novi Pazar Emergency Service annually
- **Background problem:** Emergency Service Block functioning is hampered due to old, substandard premises and improper access
- **End beneficiary:** The City of Novi Pazar - 100,410 citizens of Novi Pazar and around 85,000 of the citizens of neighbouring municipalities (Tutin, Sjenica, Raska, Zubin Potok and northern part of Kosovska Mitrovica)
- **Funding:** provided through IPA 2013 (85% EU and 15% City of Novi Pazar)

Novi Pazar Emergency Service project summary

- Approximately 1,200 m², 3 floors (with access for the ambulance)
- Basement with paediatric emergency services, fleet facilities and support staff rooms
- Ground floor, with the clinic, the reanimation unit, medical room, staff rooms,
- First floor with specialist's rooms
