However, point 21.3, selection criteria, it is stated that:

b) The candidate has provided services ... which includes provision of support in development of community based social services and/or improvement of social welfare service standards.

Since the requested experience (development of community based social services and/or improvement of social welfare service standards) is not related to the subject of the contract (youth employment), we would kindly ask to clarify if this requirement should be changed to correspond to the actual topics of this contract?

Could you please clarify whether a reference will be counted as eligible only if it actions both criteria 21.2 a) and

if it satisfies both criteria 21.3.a) and 21.3.b) under Contract Notice or will also the references satisfying only criterion 21.3.a) or only criterion 21.3.b be found eligible for the subject tender?

In order to be considered as eligible the candidate should demonstrate expertise in both fields, clearly requested under 21.3.a) **AND** 21.3.b) criteria. However, a single reference project can cover either field 21.3 a), or field 21.3 b), or both, i.e. 1 reference project should not obligatory cover both fields.

In case there is a re-examination, the first re-examination criterion will count the total number of the reference projects found eligible under 21.3. In case a reference project found eligible both under 21.3.a) and 21.3.b), this reference will only be counted once in the re-examination.
