Please for information which work premise is valid, in pdf or excel file?	<ul> <li>Plese refer to the Volume 1, Section 1, Instructions to Tender – 12.</li> <li>INFORMATION/DOCUMENTS TO BE SUPPLIED BY THE TENDERER, which states that "All tenders must comprise the following information and duly completed documents". Under point 12.1.3 the forms provided in Volume 4 have to be supplied by the tenderer (Volume 4.2.3 – Breakdown of the Lump-sum: Price including electronic version of this document in MS Excel format). In that regard, quantities specified in Volume 4 are valid and in accordance with them the tenderer should submit their financial offer.</li> <li>In the Section 3 - SCOPE OF WORK, of all Particular technical specifications (PTSs) the following is stated:</li> <li>The Contractor should be aware that the technical specifications and quantities of this document are based on indicative planning figures and he confirms that he received and possesses adequate information for the calculation of the fixed lump-sum prices;</li> <li>The Contractor takes responsibility of the full quantity risk. As specified, prior to windows and doors production, the Contractor is obliged to submit shop drawings to Supervisor for approval, as well as lists, data sheets and other openings-design documentation. In addtion, openings shall be designed in accordance with points 12.1.1.4, 12.1.2.4
4	Please provide us dimensions of sanitary devices - washbasins, shower baths, sinks (BoQ-KN-9, BoQ-KN-10, BoQ-KN-12, BoQ-KN-128).	and 12.1.2.5. The Works Contractor shall provide missing technical solutions (dimensions, details, schemas, etc.). As prescribed in General technical specification - Section 3.4.3.3 - The Contractor will solve all technical details missing in Preliminary/Conceptual design and obtain Supervisor's approvals for them. It is recomended that, the minimum dimensions of sanitary devices are: - washbasins 40x50cm - shower baths 90x90cm - sinks 50x30cm
5	In position 4.14 of HYDRO works (BoQ-KN-9 and BoQ-KN-36), no amount is entered for electrical boiler. Please for information about the quantity which is needed.	Where quantities for electric boilers is 0, these devices are not foreseen to be installed. (In facilities KN-9 and KN-36 preparation of hot water is in the central substation).
6	Please provide us the fence scheme for position 13.2.1 (BoQ-KN-36 and BoQ-KN-98).	The Works Contractor shall provide missing technical solutions (details, schemas, etc.). As prescribed in General technical specification - Section 3.4.3.3 - The Works

7	Please provide us dimensions of metal doors, position 13.2.5.2 of civil works (BoQ-KN-10).	As described in Particular technical specification (PTS) - Section 4.14 - "Installation of attic trapdoor" - required dimensions are 80/100cm.
	Since the procurement procedure for the supply of kitchen equipment is ongoing, is it possible to check the list and descriptions of kitchen equipment which should be provided?	The kitchen equipment shall be supplied through separate procurement of supplies procedure: "Supply of Equipment for the Reception Center for the Asylum Seekers", EuropeAid/139681/IH/SUP/RS.

(GTS 20.1.4, which states "Performing all works including design, construction and handover required for renovation of the kitchen and cold storage")

9	Which is the location intended for containers of construction site offices?	Exact location for the construction site containers is not determined in this point. However, it shall be agreed with the Beneficiary, upon the consultations with the Supervisor, before the commencement of the Works Contract.
10	Where is transformer station for connection of construction site electricity?	Transformer station for connection of construction site electricity is located between buildings KN-36 (kitchen and dining room) and KN-38 (accommodation building).
11	In which order will the facilities be reconstructed?	In this moment, is envisaged to firstly reconstruct KN-36. KN-11 and KN-98 should be reconstructed out of the winter season heating period. KN-9, KN-10 and KN-128 should be reconstructed before KN-12. However, the final decision will be made in agreement with Beneficiary and in line with the Volume 2/Section 3/ Special conditions, Article 17 – Programe of implementation of tasks which states: "Within 30 (thirty) days after the date of the issue of the commencement order the contractor shall submit to the <u>supervisor</u> for approval detailed <u>Programme of</u> <u>Implementation</u> of the contract (timetable) in 2 (two) hard copies and electronic format. The programme shall reflect any specific requirements set out in the contract documents and shall be in substantial conformity with the programme included in the contractor's tender, giving details on: a) the programme <u>showing the order of</u> <u>executing the works</u> and resources, labour, plant and materials, to be
