II.2.4) Description of the procurement:

The purpose of this contract is to provide technical assistance to national and local authorities to promote source separation of waste at a household level through communication and visibility activities in targeted cities/municipalities across four (4) waste management regions (RWMCS) in Serbia (Pančevo, Srem — Mačva, Duboka and Pirot).

It is part of a program named 'Source Separation in four Regions' of investment to supply equipment for waste collection (bins and containers) and for transportation (refuse collection vehicle — RCVs) that will enable local waste operators (PUCs) to organise systematic collection and transport of dry municipal solid waste fraction — recyclables, from households to the waste transfer stations or directly to secondary separation line at the four RWMCs:

'Duboko', 'Pirot', 'Srem — Mačva' and 'Pančevo'.

Under this contract, the Contractor is expected to provide following main services:

1) an insight study into local attitudes, understanding and willingness to participate in household waste separation, including a public opinion survey;

2) an communication strategy defining a co-ordinated approach for the whole 'Source Separation in four Regions' program and individual action plans for each of the participating local authorities;

3) a 'Tool Box' of communications materials that can be used at a local level to implement the action plans.

4) produced and delivered communication materials to the Ministry of Environmental Protection and each city/ municipality to support implementation of the campaign;

5) technical assistance for the implementation of the public information campaign.

Specific tasks related to output 5 are likely to include but not be limited to:

- support the local institutions, the MEP-DPM and other Project partners with the implementation of the strategy and action plans, media and information

campaigns in each city/municipality,

— the contractor is to establish at least 17 working groups which consist local authorities and local and regional PUCs at the local level to support media campaign,

- direct support to 17 local authorities will include organising at least 34 high level public events (i.e. at least 2 in each city/municipality),

- direct support in media buying time in local and national media in line with output 2

— follow-up and reporting on progress of public information campaign as well as recommendations for improvements including developing media lists,

- further communication support on environmental issues to the MEP-DPM and other project partners, if required;
